## Minutes of Great Central Railway Plc Annual General Meeting held 10:30, Saturday 13th July 2024 at Great Central Railway, Quorn Station, LE12 8AG

### 1. Formal Business:

### 1.5 Other Business:

David Morgan was not seeking re-election to the Board. The Chair thanked David for his long service to the company's Board and announced the intention to make him a Patron of the Greater Great Central Railway.

Additionally, former GCR Director Baroness Morgan has also been asked to become a Patron of the Greater Great Central Railway. Both Patrons are to be asked to support fundraising efforts for Reunification.

### 2. Question and Answer Session:

- 2.1 Q: Steve Johnson How can Gift Aid be claimed on donations?
  - A: TI responded that we try to give out forms with donations, and for some small donations some Gift Aid is automatically claimed.
- 2.2 Q: James Miller Doesn't have an email account so can't receive information electronically. What is the GCR doing to ensure that he receives communications?
  - A: TI responded to say that it is a very small list of people who do not have email, and will maintain postal communication for important information.
- 2.3 Q: Geoff Mills Noted the losses in the accounts. How are we paying for the losses.
  - A: RP explained that some of the losses can be accounted for in depreciation, and we also received a number of grants, mostly from DCRT. MR added that the Auditors will undertake a stress test analysis of the company as a 'going concern'.
- 2.4 Q: Geoff Mills -What was the outcome of the investigation into the passenger accident at Loughborough Central on 14 January 2023.
  - A: MH explained a summary of the RAIB investigation findings and recommendations, the ORR approach and our own internal investigation.
- 2.5 Nigel Harris wanted to say that it was the best AGM he had been to, and congratulated RP/TI/MH, and especially TI on an astoundingly good presentation.
- 2.6 Q: Ron Mason Why are we running trains in the midweek and on Sundays with very few people on?
  - A: MH responded that work was underway to improve the quality of the management information available to help make the right decisions on the timetable structure, a focus on marketing to ensure that we are encourage more visitors on every operating day
- 2.7 Q: Terry Holt Can we give a one-off voucher as an incentive for share purchase?
  - A: TI responded saying that it was a good idea and should be kept as an option for the future.
- 2.8 Q: Terry Holt I sit on the Accessibility Panel for EMR. What are the GCR doing to improve ramps, in particular Platform 1 at Loughborough Central?
- A: MH responded that we would include Terry in a future Accessibility Audit.
- 2.9 Q: David Putt Trains are quiet at weekends. Also, there are no leaflets in leaflet racks
  - A:MH responded with the experience of the 10-11 May Open Weekend where Facebook paid advertising was used to good effect, with a discount for local

people, and the railway filled. It showed there is a market out there to be targeted. Leaflets will be sorted

2.10 Q: Mike Callis - Mike advised that he has many useful contacts within the professional railway industry that might be of value.

A: MH responded that Mike's contacts are very useful. We also have a number of other good engagement with the railway industry including now a Partnership Agreement with Network Rail and attendance at the Rail Live event at Long Marston.

2.11 Q: Steve Johnson - Queried whether the GCR benefits financially from loco loans from the railway to others.

A: MH responded to confirm that we do.

2.12 Q: Steve Johnson - highlighted that 6990 Witherslack Hall is shown on the website as being out of traffic for service.

A: MH responded that it will be updated.

2.13 Q: Tom Stewart - Questioned whether there is a plan for permanent way maintenance into the future.

A: MH responded that there is an Asset Management Plan in development that includes permanent way assets

2.14 Q: David Wright - Queried what the long-term saving from the 2024 business restructuring was.

A: MH responded that the monthly saving was in the region of £10K per month.
